Any damage reported will be fixed to comply with the CFSB Center and billed to the individual exhibitor. All vendors are required to have Certificates of Insurance.

The contractor agrees to make every effort to allocate the exhibit the booth space indicated in the agreement. However, due to unforeseen circumstances, the contractor reserves the right to allocate space to the Exhibitor of a comparable nature in said Exhibition. The West Kentucky Boat and Outdoor Show reserves the right to deny any exclusivity in a category and the right to deny a booth to any exhibitor for any reason. Subdividing of booth space with other exhibitors is expressly prohibited without prior approval of contractor and approval is not guaranteed. Extra table requests are not guaranteed.

- **Exhibitors displaying boats must have their boats plugged prior to and during the event.**
- **Selling Merchandise: If you do not have a Kentucky Sales Tax Number you must obtain a temporary Vendors Sales Tax Permit. Exhibitors with a Kentucky Sales Tax Number must complete required Department of Revenue paperwork. Contractor will have these available during Show Check-In. The Kentucky Department of Revenue will be provided the list of exhibitors from the show.**
